The holder of this document has the competence to display three-dimensional objects in public spaces to interest viewers and increase the demand for products, services and experiences. S/he

- has knowledge of defining target groups, development of ideas and concepts for marketing purposes
- is qualified to draw sketches, make and use work drawings, presentation drawings and to build models
- has knowledge of choosing materials, products and suppliers in the local market and via the Internet
- is qualified to create colour, line and material compositions in three-dimensional spaces and masters the principles of illumination and colour impact
- is familiar with art, culture and style history
- has the competence to use ICT for communication and production
- is qualified to assess own work and perform required changes in situ
- is qualified to work appropriately professionally and financially
- is qualified to comply with rules relating to accounting, understands what it means to be independent and is qualified to work in accordance with the rules in force and according to safety and fire regulations

The final on-the-job training in a company comprises the modules 1: Trade studies, 2: Visualisation, 3: Graphic design, 4: Window dressing.

The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects.

The education/training corresponds to completed upper secondary education	Grading scale / Pass requirements The grading scale is as follows: 6 – 5 - 4 - 3 - 2 – 1 - 0. Grade 6 is the best grade. Grades 2 - 6 are passing grades. Subjects with both examination grades and overall achievement grades have been passed when the examination grade is 2 or better. "Exempted" may be used instead of numeral grades in some subjects. This means that the pupil/external candidate has previously passed corresponding or more comprehensive training in the subject. Adults may also have their attained competence assessed instead of receiving a numeral grade. The assessment "Approved" equals a passing grade.

Training comprises three years in a school/training centre. This comprises a total of 21 periods per week in general studies subjects, 78 periods per week in specialised subjects and six periods per week in elective subjects. Adult students may in some cases be exempted from the requirement for the general studies subjects.
