3. Profile of skills and competences

The holder of this document has the competence to sew all types of dresses for women, which means to design and sew clothing, taking measures, fabricating patterns and fitting clothing. S/he - is qualified to make sketches and work drawings and produce articles of clothing based on the work drawings - has knowledge of and is qualified to use various materials, and is qualified to orient himself/herself in the domestic market and abroad relating to purchasing materials and equipment - masters the use of ICT and digital aids in applications that are specific to the trade and is qualified to use the language and terminology of the trade - has knowledge of the cultural place of the trade and about the history of textiles, dresses and fashion - is qualified to use appropriate techniques, machines and tools and to consider the relationship between time and quality - has knowledge of operations, sales and marketing of design and clothing - has knowledge about international production - is qualified to make individually adapted patterns and to produce and fit clothing to various types of figures - has knowledge of customer relations, figure analysis and individual guidance for choosing design and fashion The final on-the-job training in a company comprises the modules 1: Drawing (10%), 2: Pattern design and modelling (20%), 3: Sewing models (60%), 4: Business economy studies (10%). The holder of this document also has skills on the upper secondary school level in Norwegian, English, mathematics, natural science, social studies and physical education. Adult students may in some cases be exempted from the requirement for these common-core general studies subjects.

Additional information The training period consists of four years, and can take place as two years at school followed by two years of company based training, or one year at school followed by three years of company based training, or all four years in a company combined with school based training. Two years of the training consists of a total of 588 hours in Common core subjects, 954 hours in Common programme subjects and 421 hours vocational specialization. Adult students with documented five years of work and a passed theoretical exam relevant to the subject, are qualified for a craft certificate examination according to §3-5 in the Education Act. Adult students are exempted from the requirement of common core subjects.
